Title: Apply specialized eyelash treatment services

# **Purpose**

This unit standard is intended for those who apply specialized eyelash treatment services. People credited with this unit standard are able to prepare the workstation for eyelash treatment; prepare the client for eyelash treatment; apply semi-permanent eyelashes and provide aftercare advices.

This unit standard is intended for those who work as beauty therapists.

- 1. Entry information: Prerequisite
  - Unit 1157 Demonstrate basic knowledge of workplace health and safety
- 2. Assessment evidence may be collected from a real workplace or a stimulated workplace or an appropriate simulated environment in which beauty therapy services are carried out.
- 3. All inspection, operation and maintenance procedures associated with the use of tools and equipment shall comply with manufacturers' specifications and/or workplace guidelines and instructions.
- 4. Glossary of terms:
  - 'Semi-permanent eyelashes' refer to as artificial eyelashes.
  - 'Draping' refers to cover or wrapping the client.
  - 'Protective equipment' refers to as gloves and towels.
- 5. Regulations and legislation relevant to this unit standard include the following:
  - Labour Act, No. 11, 2007
  - Occupational Health and Safety Regulations No. 18, 1997 and all subsequent amendments.
- 6. Performance of all elements in this unit standard must comply with industry standards.
- 7. This unit standard applies to all beauty therapists and range of people from different social, cultural or ethnic background.

# **Elements and Performance Criteria**

### **Element 1: Prepare the workstation for eyelash treatment**

## Range

Preparing the workstation may include but not limited to setting out products and tools for the eyelash treatment.

Products and materials include but not limited to cotton pads and earbuds.

# Performance Criteria

- 1.1 Lighting, temperature and ventilation are set in accordance with organizational requirements.
- 1.2 Equipment and materials for eyelash treatment are identified and selected in terms of their uses.
- 1.3 Tools, materials and products are prepared according to workplace requirements.

# Element 2: Prepare the client for eyelash treatment

#### Range

Preparing the client for eyelash treatment may include but not limited to draping the client, putting on the headband, positioning the client, cleansing the eye area and removing the client jewellery.

# **Performance Criteria**

- 2.1 Protective equipment's are provided to the client.
- 2.2 Client is questioned about known contra-indications to determine allergies/skin disorders.
- 2.3 Pre-care products are used to clean the eyelashes and surrounding skin.

#### Element 3: Apply semi-permanent eyelashes

#### **Range**

Semi-permanent eyelashes may include but not limited to strip lashes and single lashes.

Eyelashes may include but not limited to the shape, thickness (fine, thick, super thick), length (6mm-15mm), and colour (black, brown, blue, violet, gold, wine red and green).

### **Performance Criteria**

- 3.1 Application of different eyelash extensions is explained in terms of their benefits.
- 3.2 A range and use of currently available artificial lashes are selected and identified to meet clients' needs and expectations.
- 3.3 Eyelashes are selected according to client's eye shape.
- 3.4 Procedures to apply semi-permanent eyelashes are explained in accordance with manufactures instructions.
- 3.5 Semi permanent eyelashes are applied according to manufactures and workplace instructions.

# **Element 4: Provide aftercare advices**

#### Range

Aftercare advice may include but not limited to bathing instructions, swimming instructions, hygiene and removing of eyelash extensions.

# Performance criteria

- 4.1 Removal of eyelash extensions is explained to the client.
- 4.2 Product recommendation to the client are made accordingly to meet client requirement.
- 4.3 Future treatment program plan is recommended to meet clients' needs.
- 4.4 Clients are re-booked according to agreed treatment plan.
