Title: Apply special make-up

#### **Purpose**

This unit standard is intended for those who apply special make-up. People credited with this unit standard are able to select products, tools and equipment; prepare the client for special make-up; perform special effects make-up and provide after care advice for special effects make-up services.

This unit standard is intended for those who work as beauty therapists.

#### **Special Notes**

- 1. Entry information: Prerequisite
  - Unit 1157 Demonstrate basic knowledge of workplace health and safety
- 2. Assessment evidence may be collected from a real workplace or a stimulated workplace or an appropriate simulated environment in which beauty therapy services are carried out.
- 3. All inspection, operation and maintenance procedures associated with the use of tools and equipment shall comply with manufacturers' specifications and/or workplace guidelines and instructions.
- 4. Glossary of terms:
  - 'Sterilization' refers to a process of disinfecting tools and equipment.
  - 'Gowning/Draping' refers to as covering or wrapping the client.
- 5. Regulations and legislation relevant to this unit standard include the following:
  - Labour Act, No. 11, 2007
  - Occupational Health and Safety Regulations No. 18, 1997 and all subsequent amendments.
- 6. Performance of all elements in this unit standard must comply with industry standards.
- 7. This unit standard applies to all beauty therapists and range of people from different social, cultural or ethnic background.

#### **Elements and Performance Criterial**

# **Element 1: Select products, tools and equipment**

## Range

Make-up products may include but not limited to foundation, lipstick, eyeshadow, powder, blusher, latex, mastix, fake skin, aqua pallet, supra pallet, blood (liquid, gel, capsules).

Make-up tools may include but not limited to tweezer, sponges, brushes, earbuds, wipes, tissues, spatulas, make-up remover pads, bald cap head, net, hair and crochet needle, needle and thread.

Make-up equipment may include, but are not limited to lights, mirror, make-up chair, table and make-up box

### **Performance Criteria**

- 1.1 Suitable products and tools are selected according to the special effects make up application.
- 1.2 Area to be worked on is cleansed.
- 1.3 Tools to be used are sterilized.

#### Element 2: Prepare the client for special make-up

#### Range

Preparing the client may include but not limited to removing jewellery, removing existing make-up, gowning the client, putting on a headband and positioning the client.

### **Performance Criteria**

- 2.1 Client is positioned according to the workplace requirements.
- 2.2 Client is positioned according to the special effects make-up.
- 2.3 Client's comfort is established.
- 2.4 Headband is applied to keep the clients hair out of face.
- 2.5 A cape or towel is applied to client for protection of clothing.

### Element 3: Perform special effects make-up

### Range

Application of special effects make-up may include but not limited to bullet wounds, cuts, bruises, burns, stitching, open stomach wound and cut off leg.

# **Performance Criteria**

- 3.1 Type of special effects make-up application to be performed is identified.
- 3.2 Mastix is used when necessary.
- 3.3 Fake skin is used to create the special effects make-up when necessary.
- 3.4 Brush is used to colour the wound.
- 3.5 Fake blood is applied when necessary.

## Element 4: Provide after care advice for special effects make-up services

# Range

Aftercare advice may include but not limited to advising the client to avoid face to face contact and to avoid direct sunlight

## **Performance Criteria**

- 4.1 Client is advised on suitable skin care, make up products and make up techniques to maintain self-application and the desired image.
- 4.2 Products and tools to be used to maintain the make-up look are clearly explained.
- 4.3 Possible contraindications and adverse effect are explained to client.
- 4.4 Client is advised on cautions to be taken when removing the special effects make-up.
