marking activities

<u>Purpose</u>

This unit standard is intended for those who work in road construction and maintenance operations. People holding credit for this unit standard are able to: Plan and prepare for work; carry out operator checks and maintenance; carry out road marking operations; and clean up work area.

Being credited with this unit standard does not enable a person to drive the vehicle on an open, public road. In order to do so, a person must be in possession of a valid and current driving licence relevant to this vehicle type.

Prerequisite

- Unit 712 Comply with health, safety and environmental rules and regulations in road construction and maintenance work operations
- 2. Quality in this unit standard means adherence to contract requirements and workplace instructions.
- 3. Expected worksite production target are to be met.
- 4. Assessment evidence may be collected from a real workplace, a simulated workplace or an appropriately simulated environment in which road construction and maintenance operations are carried out.
- 5. Safe working practices include but are not limited to day-to-day observation of safety policies and procedures, and compliance with emergency procedures.
- 6. Performance of all elements in this unit standard must comply with all relevant legal and workplace requirements, contractual agreement and/or manufacturers' specifications.
- 7. Regulations and legislation relevant to this unit standard include but are not limited to the following:
 - Labour Act, No. 11 of 2007
 - Occupational Health and Safety Regulations No. 18, 1997
 - Road Traffic and Transport Regulations No. 52, 1999 and Government Notice No 53 Road Traffic and Transport Regulations
 - Road Ordinance 1972 and other relevant legislations and all subsequent amendments.

Elements and Performance Criteria

Element 1: Plan and prepare for work

Performance Criteria

- 1.1 Work instructions, including plans, specifications, quality requirements and operational details are obtained, explained, clarified and applied to the allocated task.
- 1.2 Safety requirements, including personal protective clothing and equipment are obtained from the site safety plan, workplace policies and procedures, and applied to the allocated task.
- 1.3 Traffic control requirements are obtained and implemented according to workplace requirements.
- 1.4 Plant, tools, fuel, lubricants equipment, attachments and accessories selected to carry out tasks are checked for consistency with the requirements of the job, their usability and any faults rectified or reported prior to commencement.
- 1.5 Material quantities to carry out the tasks are calculated and procured.
- 1.6 Environmental protection requirements are identified from the project environmental management plan and applied to the allocated task.

Element 2: Carry out operator checks and maintenance

Performance Criteria

- Fuel, oil, hydraulic fluid filters and water levels are checked and adjusted according to manufacturer's specifications.
- 2.2 Bolts, nuts and attachment couplings are tightened and maintained to manufacturer's specifications.
- 2.3 Functions of controls and gauges are checked and adjusted where necessary in accordance with manufacturer's specifications.
- 2.4 Standard start up and shut down procedures are conducted in accordance with the operators' manual.
- 2.5 Periodic maintenance is carried out according to operators' manual.

2.6 Paint truck and equipment are safely located when not in immediate use.

Element 3: Pilot road marking operations

Range

Safety zones may include but are not limited to gradients; sharp left-hand curves; and sharp right-hand curves.

Site conditions may include but are not limited to road width; traffic count; and day and night operation.

Performance Criteria

- 3.1 Site hazards are identified for use of paint truck.
- 3.2 Set out control points are identified and confirmed according to workplace procedures.
- 3.3 Clear, concise, and continuous communication is maintained with all other vehicles in movement during operations in accordance with workplace requirements.
- 3.4 Visibility is maintained during mobile operations for road marking.
- 3.5 Safety zone is maintained during operation in accordance with Roads Authority requirements.
- 3.6 Flashing beacons and other warning devices are operated in accordance with Roads Authority and workplace requirements.
- 3.7 Paint truck is positioned and driven according to site conditions.
